### Rules and Regulations

## 1. Registration

- 1.1) Registration must be completed as a group. Each group member is required to submit their personal details during the group registration process.
- 1.2) The stated registration fee applies to each individual participant. The total registration fee for a group will be calculated based on the final number of participants.
- 1.3) Eligibility for special discounts is assessed on an individual basis. The final discount applied to the group will depend on the number of qualifying participants.
- 1.4) All registrations must be completed before 11:59:59 PM on 14 June 2025.
- 1.5) The organisers reserve the right to close registration earlier than the stated deadline should the maximum participant capacity be reached.
- 1.6) Except where explicitly exempted by the organisers, or where the event is postponed or cancelled, registration fees are non-refundable.
- 1.7) Should any participant fail to meet the eligibility criteria for special discounts, the organisers reserve the right to revoke any previously applied discounts. Any outstanding balance must be settled in full by **1 July 2025**.

## 2. Age Categories

- 2.1) Under-13 (U13) Category: Open to participants born between 2012 and 2019.
- 2.2) Open Category: No age restriction.
- 2.3) Participants may be asked to present identification for age verification purposes.

## 3. Group Size & Membership

- 3.1) Each group must consist of a **minimum of 4** and a **maximum of 30** participants, including any backup dancers.
- 3.2) The total number of participants in a group must match the number featured in the original performance piece by the artist, including backup dancers where applicable.
- 3.3) Participants are permitted to join a maximum of two (2) groups.
- 3.4) Requests to change group members after registration must be submitted to the organisers for approval by **1 July 2025**. Approval is at the sole discretion of the organisers.

### 4. Performance Guidelines

- 4.1) Music used for the performance must be between 180 to 300 seconds in duration.
- 4.2) Music mixing is allowed, provided that all selected tracks are performed by the **same artist**.
- 4.3) Use of sound effects, props, and other elements previously utilised by the original artist is allowed and will not be classified as creative additions.
- 4.4) Creative elements such as choreography changes, additional effects, and props are allowed but not required.
